AN ACT TO AMEND ITEM (6) AND ITEM (7) OF §22435(K), CHAPTER 22, DIVISION 2, TITLE 5, GUAM CODE ANNOTATED, RELATIVE TO REALLOCATING THE SUM OF ONE MILLION SEVEN HUNDRED EIGHTY-TWO THOUSAND FIVE HUNDRED DOLLARS (\$1,782,500.00) OF THE 2007 BOND PROCEEDS FROM THE DEPARTMENT OF INTEGRATED SERVICES FOR INDIVIDUALS WITH DISABILITIES TO THE DEPARTMENT OF MENTAL HEALTH & SUBSTANCE ABUSE, FOR THE PURPOSES OF COMPLYING WITH THE AMENDED PERMANENT INJUNCTION (DISTRICT COURT OF GUAM CIV01-00041).

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Legislative Finding and Intent.** I Liheslaturan Guahan finds that in
3 compliance with and pursuant to the Amended Permanent Injunction (District Court of
4 Guam CIV01-00041) the Department of Integrated Services for Individuals with
5 Disabilities (DISID) is being integrated under the Department of Mental Health &
6 Substance Abuse. In this regard, in order to fully comply with the Amended Permanent
7 Injunction, *inter alia*, the disbursement of bond monies initially appropriated to DISID, it
8 is now necessary to de-appropriate the funds from DISID and re-appropriate them to
9 DMHSA.

10 It is the intent of I Liheslatura Guahan to facilitate the implementation of the
11 mandates set forth in the Amended Permanent Injunction by amending the
12 appropriations, as initially authorized pursuant to P.L. 29-19, accordingly.

1 Section 2. §22435(k)(6) of Chapter 22, Division 2, Title 5, Guam Code
2 **Annotated is amended to read:**

3 “(6) Two Hundred Seventeen Thousand Five Hundred Dollars (\$217,500)
4 [~~Two Million Dollars (\$2,000,000)~~] to meet obligations imposed by the
5 Permanent Injunction (District Court of Guam CIV01-00041) on the Department
6 of Integrated Services for Individuals with Disabilities, provided that said funds
7 *shall* only be made available to the Department if the District Court approves its
8 revised Guam Comprehensive Integration Plan.

9 Section 3. §22435(k)(7) of Chapter 22, Division 2, Title 5, Guam Code
10 **Annotated is amended to read:**

11 “(7) Five Million Seven Hundred Eighty Two Thousand Five Hundred
12 Dollars (\$5,782,500) [~~Four Million Dollars (\$4,000,000)~~] to meet obligations
13 imposed by the Permanent Injunction (District Court of Guam CIV01-00041) on
14 the Department of Mental Health and Substance Abuse, provided that said funds
15 *shall* only be made available to the Department *if* the District Court approves its
16 revised Guam Comprehensive Integration Plan.”

17 **Section 4. Liberal Interpretation.** This Act shall be liberally construed so as to
18 carry out its purpose in a timely manner.
