

**AN ACT MAKING APPROPRIATIONS TO THE GUAM VISITORS BUREAU FROM THE TOURIST ATTRACTION FUND FOR FISCAL YEAR ENDING SEPTEMBER 30, 2010.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. (a) Appropriations to the Guam Visitors Bureau.** The  
3 sum of Thirteen Million One Hundred Forty-six Thousand Ninety-  
4 five Dollars (\$13,146,095) is appropriated from the Tourist Attraction  
5 Fund (TAF) to the Guam Visitors Bureau (GVB) for the items and the  
6 indicated sums listed for the period of October 1, 2009, through  
7 September 30, 2010:

- 8 (1) General Administration \$ 2, 137, 197
- 9 (2) Marketing \$8,095,133
- 10 (3) Printing, Promotional \$238,875
- 11 (4) Research \$375,000
- 12 (5) Destination Development \$1,350,390
- 13 (6) Special Projects \$949,500

1           **(b) Appropriation to GVB for *Pa'a Taotao Tano'***. The sum  
2 of One Hundred Twenty-five Thousand Dollars (\$125,000) is  
3 appropriated from the Tourist Attraction Fund to the Guam Visitors  
4 Bureau for the Fiscal Year 2010 operations of Pa'a Taotao Tano to  
5 provide for the Local Match for the ANA Language Grant, the New  
6 Paa AmeriCorps, the Guahu Taotao Tano Annual Pageant, and the  
7 Northern Cultural Arts Program. Notwithstanding the general  
8 provisions of 11 GCA §30107.1 and this Act, this appropriation *shall*  
9 continue to be available until expended.

10           **(c) Appropriation to GVB for the *Tourism Education***  
11 ***Council***. The sum of Fifteen Thousand Dollars (\$15,000) is  
12 appropriated from the Tourist Attraction Fund to the Guam Visitors  
13 Bureau for the Fiscal Year 2009 operations of the Tourism Education  
14 Council. Notwithstanding the general provisions of 11 GCA §30107.1  
15 and this Act, this appropriation *shall* continue to be available until  
16 expended.

17           **(d) Appropriation to *Historic Inalahan Foundation***. The sum  
18 of One Hundred Twenty-five Thousand Dollars (\$125,000) is  
19 appropriated from the Tourist Attraction Fund to the Guam Visitors  
20 Bureau for the Fiscal Year 2009 operations of the Historic Inalahan  
21 Foundation. Notwithstanding the general provisions of 11 GCA §30  
22 107.1 and this Act, this appropriation *shall* continue to be available  
23 until expended.

24           **(e) Appropriation to *Guam Territorial Band***. The sum of  
25 Fifty Thousand Dollars (\$50,000) is appropriated from the Tourist  
26 Attraction Fund to the Guam Visitors Bureau for the Guam Territorial  
27 Band. Notwithstanding the general provisions of 11 GCA §30107.1

1 and this Act, this appropriation *shall* continue to be available until  
2 expended.

3 **(f) Appropriation to the *Guampedia*.** The sum of One  
4 Hundred Twenty-five Thousand Dollars (\$125,000) is appropriated  
5 from the Tourist Attraction Fund to the Guam Visitors Bureau for the  
6 operations of the Guam Humanities Council *Guampedia* Project.  
7 Notwithstanding the general provisions of 11 GCA §30107.1 and this  
8 Act, this appropriation *shall* continue to be available until expended.

9 **(g) Appropriation to Pacific War Museum Foundation.** The  
10 sum of Fifty Thousand Dollars (\$50,000) is hereby appropriated from  
11 the Tourist Attraction Fund to the Guam Visitors Bureau for the  
12 operations and expansion of the Pacific War Museum.
