- 13 and the Blessed Diego Catholic Church; and
- 14 WHEREAS, Ms. Misalucha returned to Guam in 2006, this time for a
- 15 concert benefiting Catholic Social Services and the Santa Bernadita Chapel in
- 16 Yigo; and
- WHEREAS, Ms. Misalucha regularly uses her talent to help raise funds
- 18 for church-related and humanitarian organizations; and
- 19 **WHEREAS**, Ms. Misalucha will perform her latest concert on our island
- 20 on Valentine's Day and which aims to support the spouses of deployed
