commending him for his willingness to provide world-

1        **BE IT RESOLVED BY THE COMMITTEE ON RULES I**

2        ***MINA'TRENTA NA LIHESLATURAN GUÅHAN:***

3        **WHEREAS**, coming from humble beginnings, Arnel Pineda made his  
4 mark in the Filipino and international music industry in several bands,

1 including, “Yjoz”, “Amo”, “New Age”, “The Rolling Bones”, and as a solo  
2 artist; and

3       **WHEREAS**, Mr. Pineda’s last band, “The Zoo”, made a name for itself in  
4 the Philippines with high-energy concerts, and excellent covers of songs that  
5 were posted on the internet from “Survivor”, “Aerosmith”, “Led Zeppelin”,  
6 “Air Supply”, The Eagles”, “Kenny Loggins”, and “Journey”; and

7       **WHEREAS**, in 2007, a member of “Journey” contacted a friend of Mr.  
8 Pineda regarding an audition for “Journey”; and

9       **WHEREAS**, in December of that year, Mr. Pineda was announced as the  
10 new lead singer of “Journey”, garnering international media coverage; and

11       **WHEREAS**, Mr. Pineda made his debut at a “Journey” Concert in Chile,  
12 to critical acclaim; and

13       **WHEREAS**, “Journey’s ” first album with Mr. Pineda, *Revelation*, debuted  
14 at Number Five on the Billboard charts, and eventually became a certified  
15 platinum record; and

16       **WHEREAS**, Mr. Pineda has a foundation in his namesake, which is set up  
17 to assist needy, homeless, and hungry children in the Philippines; and


18       **WHEREAS**, Mr. Pineda will make his first trip to Guam, for a concert  
19 with Lani Misalucha on Valentine’s Day, with the proceeds to support spouses  
20 of deployed servicemembers; now, therefore, be it
