RELATIVE TO THE BUDGETARY ALLOCATIONS OF I MINATRENTA NA LIHESLATURAN GUÅHAN FOR FISCAL YEAR 2009.

## BE IT RESOLVED BY THE COMMITTEE ON RULES OF I

## 2 MINA'TRENTA NA LIHESLATURAN GUÅHAN:

- 3 WHEREAS, the Committee on Rules has oversight of the business,
- 4 budget, design and activities of I Liheslaturan Guåhan, is constituted as the
- 5 policy-making body of I Liheslaturan Guåhan, and shall prescribe all policies
- 6 governing the administration and operations of the budget of *I Liheslaturan*

- 1 Guåhan, including, staff organization, function, personnel requirement and
- 2 rates of compensation; and
- 3 WHEREAS, the Fiscal Year 2009 Appropriations Act, P.L. 29-113,
- 4 included an appropriation to the Guam Legislature for Six Million Eight
- 5 Hundred Thousand Dollars (\$6,800,000.00) for the period of October 1, 2008 to
- 6 September 30, 2009; and
- 7 WHEREAS, the amount of One Million Seven Hundred Thousand
- 8 Dollars (\$1,700,000) was allocated for the first (1st) quarter of Fiscal Year 2009
- 9 (FY09), leaving a balance of Five Million One Hundred Thousand Dollars
- 10 (\$5,100,000); and
- 11 WHEREAS, I Liheslaturan Guåhan has recognized its fiscal
- 12 responsibilities and has taken into consideration the current economic and
- 13 fiscal restraints of the Government of Guam in preparing its FY 2009 budget.
- 14 In doing so, it is the intent of I Mina'Trenta Na Liheslaturan Guåhan to expend
- 15 lapsed funds of the outgoing senatorial offices of I Mina'Bente Nuebi Na
- 16 Liheslaturan Guåhan to cover any budgetary shortfalls; now, therefore, be it
- 17 RESOLVED, that the Committee on Rules does hereby adopt as its
- 18 budget request for the remaining nine (9) months of FY 09, the sum of Five
- 19 Million One Hundred Thousand Dollars (\$5,100,000); and, be it further
- 20 **RESOLVED**, that based on this budget request, the following
- 21 allocations shall also be adopted in accordance with the Standing Rules as the
- 22 adopted budget for I Mina'Trenta Na Liheslaturan Guåhan for the remaining

- 1 nine (9) months of FY 09, subject to the availability of funds, subject to further
- 2 modification and amendment to this adopted budget by the Committee on
- 3 Rules, and subject to transfer, by the Chairperson of the Committee on Rules,
- 4 within any various accounts of *I Liheslaturan Guåhan* (the Guam Legislature) in
- 5 order to ensure smooth operations:
- 6 Office of the Speaker \$272,280;
- 7 Majority Senatorial Offices/Standing Committees \$2,052,461;
- 8 Minority Senatorial Offices/Operations \$704,295;
- 9 Central Operations \$2,505,084;
- 10 and be it further
- 11 **RESOLVED**, that the Chairperson of the Committee on Rules is herein
- 12 directed to withhold five percent (5%) from each of the aforementioned
- 13 budget allocations, namely the Office of the Speaker, the Majority Senatorial
- 14 Offices/Standing Committees, the Minority Senatorial Offices/Operations, and
- 15 Central Operations, to be placed in the Central Operations Reserve Fund,
- subject to the disbursement of the Committee on Rules; and be it further
- 17 **RESOLVED**, that the Chairperson of the Committee on Rules is further
- 18 authorized to withhold a portion of the amount allocated to the Office of the
- 19 Speaker, to any Majority Senatorial Office/Standing Committee and/or
- 20 Minority Senatorial Office/Operations, in order to recover any monies equal to
- 21 the outstanding balance owed to the Central Operations Fund of *I Liheslaturan*
- 22 *Guåhan*; and be it further

- RESOLVED, that each of the aforementioned budget allocations, 1
- namely, the Office of the Speaker, the Majority Senatorial Offices/Standing 2
- 3 Committees, the Minority Senatorial Offices/Operations, and Central
- Operations, shall be effective January 5, 2009; and be it further 4
- RESOLVED, that the Speaker and the Chairperson of the Committee on 5
- Rules certify, and the Legislative Secretary attest to, the adoption hereof, and 6
- that copies of the same be thereafter transmitted to the members of the 7
- Committee on Rules of I Mina'Trenta Na Liheslaturan Guåhan; to the Honorable 8
- 9 Judith T. Won Pat, Ed.D., Speaker of I Mina'Trenta Na Liheslaturan Guåhan; to
- the Honorable Benjamin J.F. Cruz, Vice-Speaker of I Mina'Trenta Na 10
- Liheslaturan Guåhan; to all other Members of I Mina'Trenta Na Liheslaturan 11
- 12 *Guåhan*; and to the Clerk of the Legislature.
