- 3 **WHEREAS**, the Judiciary of Guam took the initiative to evaluate its
- 4 caseload and its processes by commissioning an independent, professional

- 1 entity, namely the National Center of State Courts, to analyze and scrutinize
- 2 its operations in 2004; and
- 3 WHEREAS, acting upon the recommendations of the National Center
- 4 for State Courts, the Judiciary of Guam saw the need to expand its capabilities
- 5 to meet the growing needs of our island community and prepare for future
- 6 demands that will be placed on our overtaxed justice system; and
- WHEREAS, the Judiciary, with the support of the Legislative and the
- 8 Executive Branches, received authorization to establish the Northern Court
- 9 Satellite through Public Law 29-109 in August 2008; and
- 10 **WHEREAS**, despite the budgetary constraints placed on the Courts, the
- 11 Judiciary of Guam, along with the Legislative and Executive Branches,
- 12 strongly believed in giving the community greater access to justice and
- 13 exercised financial prudence in order to make the Northern Court Satellite a
- 14 reality by working deliberately and diligently with the resources allocated.
- 15 The Northern Court Satellite opened within a year of being granted the
- 16 authorization; and
- 17 **WHEREAS**, the Northern Court Satellite, located in the heart of *Dededo*
- village, totals seven thousand five hundred (7,500) square feet and consists of
- 19 a Multipurpose Court Room, which can be utilized for Small Claims, Traffic,
- 20 Civil Trials, Magistrates, Criminal Trials and Occasional Appellant Hearings;
- one (1) judge's chamber with staff offices; a Jury Unit and Jury Deliberation

- 1 Room; two (2) Holding Cages and a Marshal Unit Office; a Clerks and
- 2 Ministerial Unit, and several service counters; and
- 3 WHEREAS, the Northern Court Satellite will provide a convenient
- 4 location for residents of the northern villages of Dededo, Yigo, Tamuning and
- 5 Mangilao to seek court services and obtain greater access to justice; and
- 6 WHEREAS, with the new Northern Court Satellite firmly established,
- 7 the Judiciary of Guam will be able to efficiently service Guam's growing
- 8 population and justify the need to fund a new court building in northern
- 9 Guam, especially in light of the military expansion and the anticipated
- 10 population explosion that will occur in the coming years; now, therefore, be it
- 11 **RESOLVED**, that *I Mina'Trenta Na Liheslaturan Guåhan* does hereby, on
- 12 behalf of the people of Guam, commend and congratulate the Judiciary of
- 13 Guam, on the successful opening of the Northern Court Satellite; and, be it
