1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF I**

3 **WHEREAS,** strengthening our commitment to community service and
4 civic activities is an important responsibility we all share as we continue the
5 progress generations before us have made in moving Guam forward; and

6 **WHEREAS,** Guam and her people are fortunate to know the passion of
7 hardworking, committed individuals who professionally, and voluntarily, give
8 their time and talent to make our island community a better place for all those
9 who call Guam home; and

10 **WHEREAS,** through the tireless efforts and sacrifices of exemplary
11 members of our community such as Mr. Pete L. Loriega, who has set an
12 extraordinary example of public service, we are given a great opportunity to
13 pass on this legacy of serving one another; and

14 **WHEREAS,** Mr. Loriega has been instrumental in Guam's growth as a
15 businessman and leader in Guam's Filipino community, and in civic
16 organizations for more than three (3) decades after graduating from Manila's
17 Feati University; and

18 **WHEREAS,** holding key leadership positions in the Filipino
19 Community of Guam, the Lions Club International, the Agat Guamerica Lions
20 Club, the Ambunao Iloilo Association of Guam, the Phil-American Society of
21 Architects and Engineers, and the Feati University Alumni Association, Mr.
22 Loriega has been a staunch supporter and contributor to programs and

2 raising funds for educational scholarships for Guam's bright students to
3 community service, island-wide beautification, cultural and educational
4 awareness projects, this individual has spent nearly two (2) decades giving
5 selflessly to improve our quality of life; and

7 have resulted in successful fundraising efforts totaling more than One
8 Hundred Thousand Dollars (\$100,000) as a three (3)-time King of the Filipino

10 member of the Agat Guamerica Lions Club; and

11 **WHEREAS**, Mr. Loriega's extensive efforts have garnered numerous
12 awards, certificates and recognition from Guam's leaders throughout the
13 years, including the 2009 University of the Philippines Award for *Outstanding*
14 *Filipino in Guam*; the Lions Club International *Progressive Melvin Jones Fellow*;
15 three (3) Agat Guamerica Lions Club *Lion of the Year* awards and fourteen (14)
16 *Lion King* awards; and the Filipino Community of Guam Award of Excellence
17 in the Field of Community Service; and




18 **WHEREAS**, the people of Guam, and communities throughout our
