Relative to honoring the memory and legacy of the late Eraño G. Manalo, who had served as the Executive Minister of the Iglesia Ni Cristo, a worldwide religious organization founded in the Philippines.

BE IT RESOLVED BY THE COMMITTEE ON RULES OF I

- 2 MINA'TRENTA NA LIHESLATURAN GUÅHAN:
- 3 WHEREAS, Eraño G. Manalo also known as "Ka Erdy" was born on
- 4 January 2, 1925, the fifth (5th) child of Felix Y. Manalo and Honorata de
- 5 Guzman; and
- 6 **WHEREAS**, his father Felix, who is the founder of the Iglesia Ni Cristo,
- 7 named him Erano from a reversal and elision of the term "New Era", which
- 8 his father used to describe what he felt was "a new Christian era" as the
- 9 religious group was established; and
- 10 WHEREAS, Ka Erdy initially studied law but left his studies to become
- 11 a minister of the Iglesia Ni Cristo. He started attending the church's
- 12 ministerial classes at the age of sixteen (16) and was ordained as a minister by
- 13 the age of twenty-two (22); and
- WHEREAS, he held various positions in the church, including, being
- 15 the general treasurer of the Iglesia Ni Cristo and circulation manager of the
- 16 Pasugo magazine (now known as God's Message). During this time, he wrote a
- 17 sixty-four (64) page booklet entitled Christ-God: Investigated-False; and
- 18 WHEREAS, in 1947, Eraño Manalo became the General Treasurer of the
- 19 church and married Cristina Villanueva on January 17, 1955, with whom he
- 20 has six (6) children; and

- 1 WHEREAS, in 1953, Eraño Manalo was elected as the successor to Felix
- 2 Manalo by provincial ministers, and in 1957 he became the District Minister of
- 3 Manila; and
- 4 WHEREAS, Ka Erdy demonstrated the church's responsiveness to the
- 5 needs of the poor. He initiated agrarian reforms in 1965 by establishing the
- 6 first model land reforms at resettlement farms in Palayan City, Nueva Ecija,
- 7 Philippines; and
- 8 WHEREAS, as early as 1967, four (4) years after assuming his
- 9 leadership, Ka Erdy set his vision on overseas mission and global expansion.
- 10 On July 27, 1968, he established the first congregation of the church overseas
- in Honolulu, Hawaii. Other congregations were established in San Francisco
- 12 and Los Angeles in California; and
- 13 WHEREAS, Iglesia Ni Cristo was registered with the government of
- 14 Guam on March 17, 1969, marking the continuing growth and increase in the
- 15 number of members of the church in Guam;
- 16 **WHEREAS**, Ka Erdy's leadership witnessed the construction of the \$1.2
- 17 million church, an impressive house of worship in *Harmon* with a six hundred
- 18 (600) seating capacity, dedicated to God on March 19, 1994, and which serves
- 19 as the spiritual sanctuary for the more than one thousand (1,000) worshipers
- 20 on Wednesday, Thursday and Sunday; now, therefore, be it
- 21 **RESOLVED,** that the Committee on Rules of I Mina'Trenta Na
- 22 Liheslaturan Guåhan does hereby, on behalf of I Liheslaturan Guåhan and the

- 1 people of Guam, honor the memory and legacy, of Eraño de Guzman Manalo
- 2 and does extend its sincerest Dångkolo Na Si Yu'os Ma'åse to him for his
- 3 spiritual leadership and his role through Iglesia Ni Cristo in spreading
- 4 brotherly and sisterly love among all people; and be it further
- 5 **RESOLVED**, that the Speaker and the Chairperson of the Committee on
- 6 Rules certify, and the Legislative Secretary attest to, the adoption hereof, and
- 7 that copies of the same be thereafter transmitted to the Guam Ministry of
- 8 Iglesia Ni Cristo; to his successor, his son, Eduardo Manalo; to Olivia Palala,
- 9 Consul General of the Philippines and to the Honorable Felix P. Camacho, I
- 10 Maga'lahen Guåhan.
