Relative to expressing solidarity, with and to extending the official condolences to the injured and to the families of the victims of the deadly floods caused by Tropical Storm Ondoy on behalf of the people of Guam.

BE IT RESOLVED BY THE COMMITTEE ON RULES OF I MINA'TRENTA NA LIHESLATURAN GUÅHAN:

WHEREAS, the people of Guam and the Philippines share a unique andirreplaceable bond; and

WHEREAS, Guamanians of Filipino ancestry and heritage have families
living in the Philippines. Many Guamanians of all ethnicities share strong
friendships with people in the Philippines; and

8 WHEREAS, Guam's Filipino community time and again has sacrificed 9 much for this island we share. Guamanians of Filipino ancestry and heritage 10 dedicate their time, raise funds, and volunteer to help the neediest in our 11 community, to move this island forward, and, in times of emergencies, to join 12 in the recovery of Guam; and

WHEREAS, Tropical Storm Ondoy, known internationally as Ketsana,
devastated Metro Manila and about two (2) dozen surrounding provinces on
Saturday, September 26, 2009. The storm caused flooding and mudslides,
leaving in its wake at least eighty-three (83) dead, twenty-three (23) missing
and thousands homeless; and

18 WHEREAS, the people of Guam join the survivors, the injured and the 19 families of the victims in mourning this tragedy. The people of Guam 20 understand fully the devastation of natural calamities and the need for 21 solidarity and resolve in the recovery of a people; now, therefore, be it

Bordallo, Member of Congress, U.S. House of Representatives; 11 and to the Honorable Felix P. Camacho, *I Maga'lahen Guåhan*.
