- 5 Local Union, and had expanded his knowledge on labor issues through the
- 6 ULI Training in Los Angeles, in July 2009; and
- 7 **WHEREAS**, Mr. Tommy Arceo has demonstrated kindness, compassion
- 8 and goodwill through the Bone Marrow Registry which he joined, and was
- 9 able to help an eight (8) year old child suffering from Leukemia through the
- 10 Registry; and
- 11 WHEREAS, Mr. Tommy Arceo has committed his spare time to
- 12 coaching Little League Baseball for four (4) to six (6) year olds, as well as the
- 13 Adult Softball League for the Hyatt Hotel; and
- 14 WHEREAS, Mr. Tommy Arceo endured and overcame the hardships of
- 15 taking care of five (5) children, and maintained a decent lifestyle for his
- 16 family, as his wife was sent to Afghanistan for eleven (11) months; now,

- 19 Liheslaturan Guåhan does hereby, on behalf of I Liheslaturan Guåhan and the
- 20 people of Guam, recognize Tommy Arceo, one of Guam's working class

Relative to congratulating the George Washington High School Class of 1959 on their Golden Class Reunion, and to commending them for their lifelong friendships that they have established and shared among themselves and their families.

- BE IT RESOLVED BY THE COMMITTEE ON RULES OF I
- 2 MINA'TRENTA NA LIHESLATURAN GUÅHAN:
- 3 WHEREAS, on October 31, 1936, a building was constructed and
- 4 dedicated to the hardworking, intelligent, young men and women of Guam's

- 1 Education Department, and in honor of the first President of the United States
- 2 and its Territories, as George Washington High School (GWHS) was
- 3 established by Governor Benjamin McCandlish; and
- 4 **WHEREAS**, when the educational institution opened its doors in July of
- 5 1936, Mrs. Agueda Iglesias Johnston, a prominent Chamorro woman educator,
- 6 became the first presiding Principal of George Washington High School. On
- 7 March 31, 1937, sixty-four (64) young men and women proudly graduated
- 8 from the ninth (9th) grade and in June of 1940, the first senior class graduated;
- 9 and
- 10 WHEREAS, between the years of 1945 to 1950, the GWHS campus
- 11 would relocate from Sinajaña to the former 5th Marine Depot in Mongmong,
- due to the large number of students who enrolled after the ravages of World
- 13 War II; and
- 14 WHEREAS, between the years of 1953 to 1959, the student population at
- 15 GWHS increased to over two thousand two hundred (2,200) students,
- 16 whereby the faculty and staff would have to cope with housing and
- 17 accommodating each student, transforming quonset huts into classrooms.
- 18 Soon, accreditation would begin and in 1957, GWHS became a member of the
- 19 North Central Association of Colleges and Secondary Schools (NCA); and
- WHEREAS, the commencement of the George Washington High School
- 21 (GWHS) graduating Class of 1959 was conducted on June 3, 1959 with two

- 1 hundred seventy (270) graduating high school seniors becoming the 19th class
- 2 to graduate from GWHS; and
- 3 WHEREAS, upon graduation, the GWHS Class of 1959 ventured into
- 4 the world to become outstanding achievers in various sectors of society at the
- 5 local, national and international levels; and
- 6 WHEREAS, the graduates of the GWHS Class of 1959 exemplified great
- 7 effort to reflect the mission and vision of their alma mater: "to provide
- 8 students the skills and knowledge they need to make wise decisions and be
- 9 good, productive citizens in the community"; and
- 10 WHEREAS, the GWHS Class of 1959 exemplified the mission of the
- school by working long hours in their chosen profession; living in modest
- 12 neighborhoods and raising their families with the values cherished by the
- 13 island community; struggling after WWII to create a better future for
- 14 themselves and their children by going to trade school, joining the U.S. Armed
- 15 Forces, entering into the Government of Guam workforce, becoming
- 16 educational leaders by entering the Territorial College of Guam, now the
- 17 University of Guam, under the Department of Education; and serving in other
- 18 private business enterprises, ultimately becoming valued members of the
- 19 world community by assisting when called upon, and contributing to various
- 20 civic and religious organizations; and
- 21 WHEREAS, several members of the GWHS Class of 1959 have
- volunteered their time to form a planning committee for the GWHS Golden

- 1 Class Reunion, with the goal of creating a festive and successful event,
- 2 fostering a sense of loyalty and fraternity among the 1959 graduates of
- 3 GWHS, and promoting the general welfare of classmates and support of the
- 4 high school located now in Mangilao, Guam; and
- 5 **WHEREAS**, the GWHS Class of 1959 is replete with successful leaders
- 6 within the community who have all contributed significantly to the overall
- 7 political, religious, economic, social and cultural advancements of the island
- 8 of Guam; and
- 9 **WHEREAS**, the GWHS Class of 1959 will be celebrating their "Golden
- 10 Class Reunion" at the Top o' the Mar, Nimitz Hill, on October 3, 2009, a gala
- 11 event that celebrates fifty (50) years of promoting camaraderie, friendship and
- 12 support to each other; and
- 13 WHEREAS, the members of the GWHS Class of 1959 have fully
- 14 dedicated themselves to honoring their alma mater, their families and
- 15 themselves, and pays tribute to all those who have passed away and offers
- their deepest condolences to the families on behalf of those who are present
- 17 for the Golden Class Reunion; now, therefore, be it
