1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF I**
2 ***MINA'TRENTA NA LIHESLATURAN GUÅHAN:***

3 **WHEREAS**, Guam functions and succeeds as a result of the hard work
4 of all our working class heroes that serve our island every day as workers, as
5 parents, as children, as friends, and as active citizens in our democracy; and

6 **WHEREAS**, Guam's working class heroes have long been the forgotten
7 backbone of our island, and they should be recognized for their commitment
8 and loyalty in serving the community; and

9 **WHEREAS**, there would be no tourism industry without hotel workers,
10 no schools without education professionals, no healthcare without nurses, no
11 stores without clerks, no phones without lines people, no clean streets without
12 solid waste professionals, no safe beaches and pools without lifeguards and
13 park rangers, no safety and protection without police officers and firefighters,
14 no restaurants without servers or cooks, no balanced books without
15 accountants, no clean water without water workers, no clean and maintained
16 schools and buildings without custodians and maintenance workers, and no
17 children at school without bus drivers. Guam thrives thanks to our working
18 class heroes; and

19 **WHEREAS**, Mr. William Casil has been a bus driver for ALUTIIQ for
20 the past four (4) years, transporting students of DODEA Schools, ranging
21 from elementary to high school; and

1 **WHEREAS**, Mr. William Casil has pursued a self-improvement class
2 and received a certification in Student Behavioral Management for the
3 purposes of expanding his knowledge in the job; and

4 **WHEREAS**, Mr. William Casil actively participates in his children's
5 activities as a Full-time Parent Volunteer in the Robby Webber Soccer League,
6 coordinating practice sessions and fundraisers, and taking care of equipment
7 and meals for the Team; and

8 **WHEREAS**, Mr. William Casil presents himself as being an active and
9 hard-working father by committing to his job and providing for his family,
10 while taking part in his children's activities; now, therefore, be it

11 **RESOLVED**, that the Committee on Rules of *I Mina'Trenta Na*
12 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the
13 people of Guam, recognize William Casil, one of Guam's working class
14 heroes, for his hard work and dedication, not just to his job, but to all the
15 people of Guam; and does extend *Un Dângkolo Na Si Yu'os Ma'åse'* to Mr. Casil
16 for his outstanding citizenship and accomplishments; and be it further


17 **RESOLVED**, that the Speaker and the Chairperson of the Committee on
