4 everyone in the community; and dedicated doctors tirelessly serve their fellow

6 **WHEREAS,** in December 1976, Rai Bok Hong, M.D., came to Guam to
7 serve its people as one (1) of only two (2) otolaryngologists; and

8 **WHEREAS,** two (2) years later, Dr. Hong became an active staff
9 member at the Guam Memorial Hospital; and

10 **WHEREAS,** in his time on the island, Dr. Hong has treated all kinds of
11 ailments in children, adolescents, and adults; and has also helped patients
12 suffering from head and neck cancers; and

13 **WHEREAS,** Dr. Hong is a member of several professional medical
14 organizations, including the Guam Medical Society, the American Medical
15 Association, and the American Academy of Otolaryngology; and

16 **WHEREAS,** Dr. Hong also serves the island as an Elder in the First
17 Presbyterian Church of Guam; and




18 **WHEREAS,** after thirty-three (33) years of healing the island's people,
19 Dr. Hong is closing his clinic; now, therefore, be it
