**Relative to recognizing the *I TINAYUYOT I LISÅYU*
team for achieving a great milestone in the preservation
of the *Chamorro* culture.**

1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF I**
2 ***MINA'TRENTA NA LIHESLATURAN GUÅHAN:***

3 **WHEREAS, *I TINAYUYOT I LISÅYU*** is a ninety (90) minute long, full-
4 length video of quality visuals and stunning graphics covering the Joyful,
5 Sorrowful, Glorious, and Luminous Mysteries, and is filmed against the
6 beautiful backdrop of Guam's Catholic churches, scenery, and sacred
7 scripture; and

8 **WHEREAS, *I TINAYUYOT I LISÅYU*** was developed because of the
9 need to equip *Chamorro* language learners with the tools that will provide
10 them a better chance of success in speaking and understanding *Chamorro*; and

11 **WHEREAS, *I TINAYUYOT I LISÅYU*** is a video-based tool aimed at
12 preserving our *Chamorro* language and the custom of the *Lisåyo*, teaching users
13 to pray the rosary in *Chamorro*, to annunciate the prayers correctly, and to gain
14 a deeper understanding of the prayer and the *Chamorro* words used in the
15 prayer; and

16 **WHEREAS, *I TINAYUYOT I LISÅYU*** is a product of a grass roots level,
17 free enterprise company named Powerhouse Production, which assumed all
18 of the business responsibilities in coordinating and financing this DVD, and
19 with the development phase of this project spanning over one year (May 2008
20 to October 2009), consisting of planning, coordinating and implementing the
21 production schedule; and

1 **WHEREAS, I TINAYUYOT I LISÁYU** is an interactive DVD that uses
2 video technology to engage sight and sound to effectively stimulate emotion
3 among its viewers, allowing them to see, hear and read *Chamorro* in a platform
4 that provides a new method of learning; and also allowing its users to practice
5 whenever and wherever they may wish; and offering families or individuals,
6 who do not have access to fluent *Chamorro* speakers, a way to make the
7 language readily available in the comfort and privacy of their homes; and

8 **WHEREAS, I TINAYUYOT I LISÁYU** is the first video-based *Chamorro*
9 language learning tool to incorporate subtitles in *Chamorro*, allowing the user
10 to read and follow along on-screen; this all-in-one DVD makes *Chamorro*
11 words easy to understand and provides a closer look at this special prayer,
12 which has been with the *Chamorro* people for many generations; and


13 **WHEREAS, I TINAYUYOT I LISÁYU** is a product made possible by

22 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the


1 people of Guam, recognize the *I TINAYUYOT I LISÅYU* team for achieving a

9 J.C. Reyes; and to the Honorable Felix P. Camacho, *I Maga'lahen Guåhan*.


