Relative to approving the expenditure of Forty Three Thousand Three Hundred Four Dollars (\$43,304) for the purpose of restoring salary reductions to Central Operations employees of *I Liheslaturan Guåhan*.

1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF I**
2 ***MINA'TRENTA NA LIHESLATURAN GUÅHAN:***

3 **WHEREAS,** the salaries of Central Operations employees of *I*
4 *Liheslaturan Guåhan* was reduced by ten percent (10%) in March 2007, during
5 the Twenty-Ninth (29th) term of *I Liheslaturan Guåhan*, as a cost-cutting
6 measure; and

7 **WHEREAS,** in November 2007, still during the Twenty-Ninth (29th)
8 term of *I Liheslaturan Guåhan*, salary levels were partially restored by five
9 percent (5%), at which level they have remained until the present time; and

10 **WHEREAS,** during this current term, *I Mina'Trenta Na Liheslaturan*
11 *Guåhan* has realized significant levels of cost-avoidances through various

1 measures, including the reduction of power and water consumption and self-
2 disposal of solid waste; and

3 **WHEREAS**, funding from said cost-avoidances can now be used to fully
4 restore the salary levels for Central Operations employees to what they
5 originally earned; now, therefore, be it

6 **RESOLVED**, that the Committee on Rules of *I Mina'Trenta Na*
7 *Lihselaturan Guåhan*, on behalf *I Lihselaturan Guåhan* and the people of Guam,
8 does hereby approve the expenditure of Forty Three Thousand Three
9 Hundred Four Dollars (\$43,304) for the purpose of restoring salary reductions
10 to Central Operations employees of *I Lihselaturan Guåhan*; and be it further

11 **RESOLVED**, that the Speaker and the Chairperson of the Committee on
12 Rules certify, and the Legislative Secretary attest to, the adoption hereof, and
13 that copies of the same be thereafter transmitted to Vince P. Arriola, Executive
14 Director of *I Mina'Trenta Na Lihselaturan Guåhan*; and to the Honorable Felix P.
15 Camacho, *I Maga'lahaen Guåhan*.
