3 **WHEREAS,** *Islander Registry* LLC is officially registered with the U.S.
4 Patent and Trademark Office with specific licensing, marketing and
5 distribution of its own products; and

6 **WHEREAS,** *Islander Registry* LLC evolved into a corporation that is
7 based in Phoenix, Arizona, and is responsible for coordinating and promoting
8 special events, such as the *Coconut Olympics*, and many other events involving
9 the Pacific Islander Community; and

10 **WHEREAS,** *Island Registry* LLC manages the *Island Registry.com*
11 website, which was developed by John and Tina Cruz as a hobby to start a
12 family-oriented social network for Pacific Islanders to maintain a connection
13 with their heritage and with fellow islanders; and

14 **WHEREAS,** the *Islander Registry* website, upon celebrating its First (1st)
15 Anniversary, had a little over three thousand (3,000) registered members; and
16 as it celebrates its Second (2nd) Anniversary, it has experienced significant
17 growth of its membership over the past year, with over six thousand (6,000)
18 members worldwide, seventy thousand (70,000) photos, one thousand (1,000)
19 videos, and hundreds of groups and forums on its website; and

20 **WHEREAS,** *Islander Registry* LLC, along with its *Islander Registry*
21 website, will celebrate its Second (2nd) Anniversary on June 5, 2010, on Guam,

1 which will include a concert to memorialize one of Guam’s local entertainers,
2 the late Frank “Bokonggo” Pangelinan, as well as many of Guam’s favorite
3 musicians and performers, and the hosting of the *Coconut Olympics*; and

4 **WHEREAS**, the vision of *Island Registry* LLC is to form a coalition
5 dedicated to promoting the values of culture, tradition, heritage and beliefs of
6 Pacific Islanders; now, therefore, be it
