1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF I**
2 ***MINA'TRENTA NA LIHESLATURAN GUÅHAN:***

3 **WHEREAS**, a total of sixty-five (65) young men graduated from Father
4 Duenas Memorial School in 1965; and

5 **WHEREAS**, upon graduation, the Father Duenas Memorial School Class
6 of 1965 ventured into the world to become outstanding achievers in various
7 sectors of society at the local, national and international levels; and

8 **WHEREAS**, the graduates of Father Duenas Memorial School Class of
9 1965 exemplified great effort to reflect the mission and vision of their Alma
10 Mater, to provide students the skills and knowledge they need to make wise
11 decisions and be good, productive citizens in the community; and

12 **WHEREAS**, the Father Duenas Memorial School Class of 1965
13 exemplified the mission of the school by working long hours in their chosen
14 profession; raising their families with the values cherished by the island
15 community; struggling to create a better future for themselves and their
16 children by going to trade school, joining the U.S. Armed Forces, and valiantly
17 serving in the Vietnam War, entering into the Government of Guam
18 workforce, becoming educational leaders, attending the Territorial College of
19 Guam, now the University of Guam, serving in other private business,
20 professional enterprises, ultimately becoming valued members of the world
21 community by assisting when called upon, and contributing to various civic
22 and religious organizations; and

1 **WHEREAS**, the Father Duenas Memorial School Class of 1965 is replete
2 with successful leaders within the community who have all contributed
3 significantly to the overall political, religious, economic, social and cultural
4 advancements of the island of Guam; and

5 **WHEREAS**, in keeping with tradition, many sons of the 1965 Alumni
6 have graduated or are current students at the Father Duenas Memorial School;
7 and

8 **WHEREAS**, the Father Duenas Memorial School Class of 1965 is
9 celebrating forty-five (45) years of camaraderie, friendship and support to
10 each other; and

11 **WHEREAS**, the members of the Father Duenas Memorial School Class
12 of 1965 in celebrating their Forty-fifth (45th) Reunion, honor their Alma Mater,
13 their families and themselves, and pay tribute to all those members who have
14 passed away; and

15 **WHEREAS**, as part of their reunion activities, the Class of 1965 planned
16 a trip to Rota; a donation of sports equipment, books and other educational
17 material to elementary and high school students in Rota; a family picnic at
18 *Urunao*; and alumni mass and dinner; and other activities, including
19 fundraising to off-set the travel cost to Rota; and

20 **WHEREAS**, while in Rota, members of the Class were given the
21 opportunity to meet with elementary and high school students to talk about
22 career goals and opportunities; and

1 **WHEREAS**, the 1965 Alumni have been part of the growth of the Father
2 Duenas Memorial School by supporting fundraising efforts, such as the Gala
3 Event held recently to raise money for their library, and participated in their
4 Annual Alumni Basketball Tournament, Golf Tournaments, and 5K Walk/Run
5 events; and

6 **WHEREAS**, the 1965 Alumni have pledged to continue to support the
7 personal growth and development of Father Duenas Memorial School
8 graduates through the establishment of a scholarship fund; now, therefore, be
9 it

10 **RESOLVED**, that the Committee on Rules of *I Mina'Trenta Na*
11 *Lihselaturan Guåhan* does hereby, on behalf of *I Lihselaturan Guåhan* and the
12 people of Guam, recognize and congratulate the members of the Class of 1965
13 of Father Duenas Memorial School as they celebrate their Forty-fifth (45th)
14 High School Reunion, and does commend them for their contributions to
15 Guam and Rota; and be it further

16 **RESOLVED**, that the Speaker and the Chairman of the Committee on
