15 the Outstanding Work Center of the Quarter for July 1996, October 2002, March
16 2004, and May 2004; and

18 and he will be sorely missed; and all his colleagues and friends wish him the
19 best as he pursues his interests during his well deserved retirement; and

20 **WHEREAS,** through his dedication and his commitment to public
21 service, David Quintanilla has positively impacted and contributed to the
22 efficiency of the Port Authority's operations; now, therefore, be it
