3 **WHEREAS,** Cecilia Guerrero Martinez was born on December 31, 1938,
4 in *Hagåtña*. She is the daughter of Juan Benavente Guerrero and Rosita Blas
5 Guerrero, and is the fifth (5th) child of ten (10) siblings, with five (5) brothers,
6 four (4) sisters, and one (1) reared brother; and

7 **WHEREAS,** Cecilia Guerrero Martinez is blessed with three (3) children
8 and their spouses: James A. Martinez and Joyce Kaneshiro; Lenora Martinez
9 and Joseph A.C. Sanz; and Yvonne Martinez Cruz; and

10 **WHEREAS,** Cecilia is doubly blessed with ten (10) grandchildren:
11 Christopher, Christine, Camarin, Kaylene and Kiroshi Kaneshiro; Jonah
12 Christian and Josiah Christopher Sanz; Jon Anthony Martinez Cruz and
13 Cheryl Untalan; Jay Andrew Martinez Cruz, and Jose Andre Martinez Cruz;

15 **WHEREAS,** Cecilia graduated in 1958 from the Academy of Our Lady
16 of Guam in *Hagåtña*, Guam; and

17 **WHEREAS,** from September 11, 1994 to July 1996, Cecilia began her
18 public service journey with the government of Guam Department of
19 Administration, working as an Employee-Management Relations Officer II
20 with the Employee-Management Relations Branch; she then served as the
21 Equal Employment Officer of the University of Guam from July to October
22 1996. Cecilia returned to the Department of Administration to work as the

1 Employee-Management Relations Officer II, from October 1996 to January
2 2003, and she quickly rose through the ranks, working as the Personnel
3 Services Administrator, from January 2003 to the present, with the Division of
4 Personnel Management within the Department of Administration; and

5 **WHEREAS**, prior to her tenure with the government of Guam, Cecilia
6 worked as a civil service employee with the U.S. Navy Commissary Store,
7 Naval Station, Guam, as a Stock Control Clerk, GS-4, from January 1959 to
8 May 1962. She was a Secretary, GS-5, from May 1962 to July 1964, with the
9 Trust Territory of the Pacific Islands Headquarters, Guam. Cecilia furthered
10 her career, working as a Secretary, GS-5, from July 1964 to August 1970; and
11 from August 1970 to May 1976, she was promoted, and worked as the Federal
12 Women's Program Coordinator, GS-160-9, at the U.S. Navy Public Works
13 Center, Guam. She then became an Equal Employment Specialist, GM-260-12,
14 from May 1976 to May 1982, working at the Consolidated Industrial Relations
15 Office, Naval Station, Guam; and then was employed as the Equal
16 Employment Manager, GM-260-13, from May 1982 to January 1994, retiring
17 from the Human Resources Office, Naval Station, Guam; and

18 **WHEREAS**, Cecilia's professional training embraced specialized areas
19 in Management, Personnel Management, and Equal Employment
20 Opportunity; and

1 **WHEREAS**, Cecilia led a busy but well-balanced life of leadership in
2 civic organizations, including serving for many years as a Board Member of
3 the NavMar Federal Credit Union at Naval Station; and

4 **WHEREAS**, Cecilia G. Martinez has selflessly dedicated many years of
5 her life in public service for Guam and her people; now, therefore, be it

6 **RESOLVED**, that the Committee on Rules of *I Mina'Trenta Na*
7 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the
8 people of Guam, recognize, honor and congratulate Ms. Cecilia G. Martinez
9 on her retirement, and for dedicating over sixteen (16) years of government
10 service; and does further extend a sincere *Un Dångkulo Na Si Yu'os Ma'åse* to
11 her for the outstanding contributions she made in improving the quality of life
12 for the betterment of our island community; and be it further


