Relative to approving an additional budgetary allotment for the Committee on Ethics and Standards of *I Mina'Trenta Na Liheslaturan Guahan* in the amount of Five Thousand Dollars (\$5,000).

1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF I**
2 ***MINA'TRENTA NA LIHESLATURAN GUAHAN:***

3 **WHEREAS**, the Committee on Ethics and Standards was appointed on
4 August 20, 2009, and received an allocation of funds by the Committee on Rules in
5 order to exercise the powers and perform the duties granted to it, including
6 organizing its staff and the hiring of such secretarial, professional and stenographic
7 help as necessary, pursuant to Sections 18.02 and 18.03 of the Standing Rules; and

8 **WHEREAS**, an allocation of Fifteen Thousand Dollars (\$15,000) was
9 allocated to the Committee through Resolution No. 233-30 (LS), adopted on
10 October 30, 2009; and

11 **WHEREAS**, an additional allocation of Ten Thousand Dollars (\$10,000)
12 was allocated to the Committee through Resolution No. 277-30 (COR), adopted on
13 February 1, 2010; and

14 **WHEREAS**, the total allocation has been exhausted and the Committee has
15 expenses remaining to be paid and requires a supplementary budget of Five
16 Thousand Dollars (\$5,000); and

1 **WHEREAS**, any unexpended balance remaining in the Committee’s budget
2 *shall* be returned by the Committee on Rules to Central Operations at the end of
3 the term; now, therefore, be it

4 **RESOLVED**, that the Committee on Rules of *I Mina’Trenta Na*
5 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the
6 people of Guam, allocate Five Thousand Dollars (\$5,000) to the Committee on
7 Ethics and Standards as its supplemental budget, pending the submission of a
8 formal budget request by the Committee; and be it further

9 **RESOLVED**, that the Speaker and the Chairperson of the Committee on
10 Rules certify, and the Legislative Secretary attest to, the adoption hereof, and that
11 copies of the same be thereafter transmitted to the Honorable Judith P. Guthertz,
12 Senator and Chairperson of the Committee of Ethics and Standards of *I*
13 *Mina’Trenta Na Liheslaturan Guåhan*; and to the Honorable Felix P. Camacho, *I*
14 *Maga’lahen Guåhan*.
