

**I MINA'TRENTA NA LIHESLATURAN GUAHAN  
2010 (SECOND) Regular Session**

**Resolution No. 497-30 (LS)**

**Relative to the disapproval of any Administrative Rules and Regulations, or agency plans, submitted to *I Liheslatura* between September 1, 2010 and January 3, 2011.**

1        **BE IT RESOLVED BY I MINA'TRENTA NA LIHESLATURAN**  
2 **GUÁHAN:**

3        **WHEREAS,** *I Liheslatura* finds that Rules and Regulations, and agency  
4 plans, have been submitted for legislative approval in the last few months of the  
5 term of *I Mina'Trenta Na Liheslaturan Guáhan*, which have potential for  
6 significant fiscal and welfare impacts to the people of Guam; and

7        **WHEREAS,** these Rules and Regulations, and agency plans, require  
8 comprehensive review extending beyond the current legislative term; and

9        **WHEREAS,** a new administration will take office in less than seven (7)  
10 days, and may desire to review and improve upon these proposed Rules and  
11 Regulations, and agency plans, that their administration would have to enforce or  
12 oversee; and

13        **WHEREAS,** the Administrative Adjudication Law allows for the default  
14 approval of Rules and Regulations, if *not* amended or rejected by *I Liheslatura*  
15 within ninety (90) days of transmittal. However, given the current circumstances,  
16 the default approval of the remaining transmitted Rules and Regulations, and

1 agency plans, without further public input and input by the new administration is  
2 contrary to the best interests of the public; now, therefore, be it

3 **RESOLVED**, that, notwithstanding the Administrative Adjudication Law,  
4 any Rules and Regulations, *or* agency plans, submitted to *I Liheslatura* pursuant to  
5 the Administrative Adjudication Law, Title 5, Guam Code Annotated, Chapter 9,  
6 Article 3, between September 1, 2010 and January 3, 2011, are hereby  
7 disapproved, and *shall not* lapse into law based on the inaction of *I Liheslatura*;  
8 and be it further

9 **RESOLVED**, that the Speaker certify, and the Legislative Secretary attest  
10 to, the adoption hereof, and that copies of the same be thereafter transmitted to the  
11 Honorable Edward J.B. Calvo, Governor-elect; and to the Honorable Felix P.  
12 Camacho, *I Maga'lahaen Guåhan*.
