WHEREAS, the Hospital Development Foundation seeks, pursues and solicits other funding sources through grants, corporate sponsorships, donations, and other resources for the Corporation in furtherance of the Corporation’s purpose

WHEREAS, the Hospital Development Foundation shall have all general powers as allowed under the Corporation laws of the Territory of Guam and the United States
