

Relative to requesting the Congresswoman Madeleine Z. Bordallo to introduce legislation to rename the Guam Main Facility (GMF) Post Office in Barrigada to Juan C. Pablo Post Office in the United States House of Representatives to honor achievements and service to the United States Postal Service and the people of Guam

1 **BE IT RESOLVED BY I MINA' TRENTA NA LIHESLATURAN GUÅHAN:**

2 **WHEREAS**, the late Mr. Juan C. Pablo dedicated his life to an outstanding
3 career in service to the United States postal Service, starting employment after
4 successfully competing for his position within the merit system; and

5 **WHEREAS**, his superiors recognized his management potential and
6 continually challenged him with increasing responsibilities, he successfully met each
7 challenge with outstanding performance; and

8 **WHEREAS**, Mr. Pablo was further recognized and finally given the reins to
9 manage the local postal operations with an appointment and promotion to
10 Officer in Charge on June 30, 1973; and

11 **WHEREAS**, on September 29, 1973, Mr. Juan C. Pablo became the first
12 Chamorro whose exemplary tenure and service under the postal merit system earned
13 the position and was designated Post Master of the Guam Main Facility; and

1 **WHEREAS**, during his tenure as Post Master of the Guam Main Facility, Mr.
2 Pablo continually and successfully advocated for more resources needed to improve
3 the postal service for the people of Guam; and

4 **WHEREAS**, due in large part to his advocacy, the postal service agreed to
5 allocate funds for the construction of the most modern and advance post office
6 facility of its time to meet the increasing population and customer needs; and

7 **WHEREAS**, aside from being Post Master of the Guam Main Facility, Mr.
8 Pablo contributed his management experience generously to his municipality of
9 Barrigada in service as member of the municipal council; and

10 **WHEREAS**, he extended his civic service to the parish of San Vicente/ San
11 Roke parish council, where he was part of the core of the faithful that raised the
12 money and built the present day San Vicente Church; and

13 **WHEREAS**, the People of Guam, for his achievements and contribution wish
14 to bestow a fitting and lasting recognition: now therefore be it

15 **RESOLVED**, that *I Mina' Trenta Na Liheslaturan Guåhan* does hereby, on
16 behalf of the people of Guam, petition Congresswoman Madeleine Bordallo to
17 initiated the process to memorialize Mr. Juan C. Pablo's contributions the United
18 States Postal Service and the people of Guam by naming the Guam Main Facility in
19 Barrigada after the late Juan C. Pablo; and be it further

20 **RESOLVED**, that the Speaker certify, and the Secretary of the Legislature
21 attest to, the adoption hereof, and that copies of the same be thereafter transmitted to,
