WHEREAS, Mr. Manuel "Mañu" Cruz Paulino was born on June 17, 1929 in Inarajan. Their relationship evolved against all odds and as the story goes Maria's godmother, Ms. Maria R. San Nicolas, interceded with Maria's parents when she and *Mañu* decided to marry; and

WHEREAS, the couple exchanged vows on March 7, 1959, at the Agaña Cathedral Catholic Church in *Hagåtña* with the Father Vicente T. Martinez officiated the ceremony and *Mañu* and Maria's godparents – Mr. Jesus D. Paulino and Ms. Maria R. San Nicolas as is customary in the *Chamorro* culture were the witnesses. They exchanged vows, and today, continue living happily ever after; and
