1 **BE IT RESOLVED BY I MINA' TRENTA NA LIHESLATURAN GUÅHAN:**

2 **WHEREAS**, for many years, the farmers of Guam have provided our island  
3 community with fresh vegetables, fruits, fish, and non-edible horticultural products  
4 for beautification purposes; and

5 **WHEREAS**, the farmers of Guam continue to advance their mission of  
6 promoting and supporting a local agriculture industry by strengthening the  
7 community between farmers and consumers, thus providing for a better quality of  
8 life; and
