

WHEREAS, Antonio "Tony" D. Juanico began his career with the United States Navy in 1948 when he was employed by the naval government contractor MAS-DELCO; and

WHEREAS, when MAS-DELCO closed its operations on Guam in 1952, Tony was hired as a civilian employee and continued his career as a mechanic, serving both Naval Air Station, Tiyan and Naval Station, Santa Rita until he retired in 1995, after forty-three years of service; and

WHEREAS, even after he retired, Mr. Juanico still served various contractors that serviced the Navy; and

WHEREAS, his co-workers have said Tony trained many mechanic apprentices who later became successful in their own respective careers, some reaching management level and

WHEREAS, Mr. Juanico is known also for his knowledge in various

specialties, resiliency, can-do attitude, and application of both practical and technical knowledge; and

WHEREAS, has been honored with several awards as both a civilian and contract employee throughout his sixty-one year commitment to the island, military, and country; and

WHEREAS, this amount of dedication and loyalty to all sectors of government should be saluted; now therefore it be
