3 **WHEREAS**, the Ministry of Saint Paul Assembly of God Church recognized
4 the need to share the Gospel of Jesus Christ through a Christian educational system;

5 **WHEREAS**, St. Paul Christian School North was established on the campus of
6 the former Trinity Christian School last year in response to the expanding population
7 of northern Guam; and

8 **WHEREAS**, St. Paul Christian School North's dedicated, creative and
9 energetic staff revitalized the campus and undertook the challenge of transforming the
10 facility from the Crusaders to the Warriors; and

11 **WHEREAS**, St. Paul Christian School North opened its doors for K-3 to 12th
12 grade students with a new cafeteria and a completely refurbished playground; and

13 **WHEREAS**, St. Paul Christian School North has RenWeb, a school
14 management program, that integrates the school and home and improves
15 communication between the school staff, parents and students.

16 **WHEREAS**, St. Paul Christian School North had a very exciting and fulfilling
17 year with increases in enrollment that allowed for multiple student sports and

1 academic organizations such as the National Junior Honor Society and the National
2 Honor Society; and

3 **WHEREAS**, St. Paul Christian School North successfully earned a full six
4 year accreditation from the Western Association of Schools and Colleges (WASC)
5 and the Association of Christian School International (ACSI); now therefore be it

6 **RESOLVED**, that the Committee on Rules of *I Mina'Trenta Na Liheslaturan*
7 *Guåhan* hereby on behalf of the people of Guam, join in recognizing and
8 congratulating St. Paul Christian School North for completing their first school year
9 and conducting their first commencement exercises for the Class of 2009; and be it
