- 8 twenty-one (21) years in Guam's public schools, consisting of C.L. Taitano
- 9 Elementary School, Chalan Pago-Ordot Elementary School, and currently at H.B.
- 10 Price Elementary School, as a Cooking Assistant as well as preparing and cooking
- breakfast and lunch meals; and
- WHEREAS, Ms. Antonia Villagomez commits her spare time being a member
- of the Guam Sunshine Lion's Club for over a year now helping the community with
- various projects, making a positive impact for our island; and
