1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF I**
2 ***MINA'TRENTA NA LIHESLATURAN GUÅHAN:***

3 **WHEREAS**, Guam functions and succeeds as a result of the hard work
4 of all our working class heroes that serve our island every day as workers, as
5 parents, as children, as friends, and as active citizens in our democracy; and

6 **WHEREAS**, Guam's working class heroes have long been the forgotten
7 backbone of our island, and they should be recognized for their commitment
8 and loyalty in serving the community; and

9 **WHEREAS**, there would be no tourism industry without hotel workers,
10 no schools without education professionals, no healthcare without nurses, no
11 stores without clerks, no phones without lines people, no clean streets without
12 solid waste professionals, no safe beaches and pools without lifeguards and
13 park rangers, no safety and protection without police officers and firefighters,
14 no restaurants without servers or cooks, no balanced books without
15 accountants, no clean water without water workers, no clean and maintained
16 schools and buildings without custodians and maintenance workers, and no
17 children at school without bus drivers. Guam thrives thanks to our working
18 class heroes; and

19 **WHEREAS**, Mr. Ronnie Jguimarey has been employed with the Guam
20 Fire Department (GFD) as a Firefighter II for seventeen (17) years; and

21 **WHEREAS**, Mr. Ronnie Jguimarey not only performs the duties of a
22 Firefighter, but is also a Medical Transport Attendant; and

1 **WHEREAS**, Mr. Ronnie Jguimarey has dedicated many years to
2 ensuring the safety of the people of Guam, and working countless numbers of
3 hours while still making time for his wife and two (2) children; now,
4 therefore, be it

5 **RESOLVED**, that the Committee on Rules of *I Mina'Trenta Na*
6 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the
7 people of Guam, recognize Ronnie Jguimarey, one of Guam's working class
