RELATIVE TO OBSERVING THE UNIVERSITY OF GUAM'S  
CHARTER DAY CELEBRATION AND TO COMMENDING  
THE UOG PRESIDENT, FACULTY, STAFF, STUDENTS, THE  
BOARD OF REGENTS, AND THE 2010 CHARTER DAY  
COMMITTEE FOR THEIR WORK IN CONTINUING THE  
TRADITIONAL CELEBRATION OF THIS AUSPICIOUS AND  
HISTORIC EVENT.

BE IT RESOLVED BY I MINA'TRENTA NA LIHESLATURAN

1        WHEREAS, on March 9, 2010, the University of Guam ("the  
2 University"), a land grant institution, will observe its Charter Day  
3 Celebration, marking its founding in 1952 as the Territorial College of Guam  
4 and its renaming as the University of Guam in 1968; and

      WHEREAS, the Territorial College of Guam, which was founded in 1952,  
offering limited classes at the old George Washington High School campus in  
Mongmong, developed from a two (2) year teacher training institution to a

Land Grant University in 1972 that today offers a full range of undergraduate programs and graduate studies; and

**WHEREAS**, the Territorial College of Guam, having relocated to its present one hundred (100) acre campus over-looking Pago Bay in Mangilao in 1960, was renamed the "University of Guam" by the ninth (9th) Guam Legislature after being accredited for the maximum period by the Western Association of Schools and Colleges ("WASC") in 1968; and

**WHEREAS**, the University of Guam's first Charter Day was proclaimed on December 17, 1968, by the Honorable Governor Manuel F.L. Guerrero through Executive Order 74-09; and

**WHEREAS**, the year 2010 marks the 58<sup>th</sup> year of the founding of the University of Guam and the 42<sup>nd</sup> Charter Day celebration; and

**WHEREAS**, while the University pursues its mission of providing resident instruction and research to the people of Guam, it also provides our neighbors throughout Micronesia the opportunity to achieve higher education; and

**WHEREAS**, the University of Guam, in its quest to maintain its tradition of excellence, continues to contribute to the island's social, cultural, political and economic advancement; and

**WHEREAS**, the theme for this year "UOG Green II: Making a Difference Starts with You," reflects the University's efforts to promote individual responsibility and culture change towards a sustainable campus community

and lifestyle that will serve as a model for our island people, the people of the Western Pacific, and the people of the Asian Pacific Rim nations, through the University's vision and mission of research, education and service; and

**WHEREAS**, the 2010 Charter Day activities will showcase Guam's cultural, social, educational and recreational activities by inviting the People of Guam to visit the Mangilao campus during the week and share in these experiences; and

**WHEREAS**, Robert A. Underwood, Ed.D., President of the University, appointed the 2010 Charter Day Committee to organize this year's activities, whose membership includes: Pedro R.
