WHEREAS, Law Day is a celebration of our nation's great heritage of liberty, justice and equality under law; and

WHEREAS, a viable democracy requires understanding of the nature and basis of our freedoms and recognition of the individual responsibilities that these freedoms represent; and

WHEREAS, Law Day is an opportunity to celebrate the Constitution and the laws that protect our rights and liberties and to recognize our responsibility as citizens to uphold the values of a free and just society; and

WHEREAS, in 1958, Law Day was proclaimed by President Dwight D. Eisenhower and was reaffirmed thru a joint resolution in Congress in 1961; and

WHEREAS, all citizens, both young and old, need to understand their rights and responsibilities under the law to become effective participants in our nation's civil life;

WHEREAS, Law Day is annually celebrated on May 1 of every year as a "special day of celebration by the American people in appreciation of their liberties and to provide an occasion for rededication of the ideals of equity and justice under the laws."

WHEREAS, the Law Week 2010 theme, "Law in the 21st Century: Enduring Traditions, Emerging Challenges", encourages all to examine the impending transformation of our island with the law changing dramatically, both shaping and adapting to new conditions created by advances in technology and globalization; and

WHEREAS, in this global era, matters such as human rights, criminal justice, intellectual property and environmental regulations become concerns we all share and the simplest business transactions and disputes require cultural understanding; and

WHEREAS, Law Day 2010 provides us with an opportunity to understand and appreciate the emerging challenges that confront us today, while taking pause to consider and identify legal traditions essential to our conception of justice—traditions that we must strive together to maintain; and

WHEREAS, the Guam Bar Association in coordination with the Judiciary of Guam and the District Court of Guam has scheduled numerous events that will take place during the course of the week to include: a 5k race entitled "Race Judicata", a one day Law Fair at the Micronesia Mall, a State of the Judiciary Address, local and federal courthouse tours, fairy tale mock trials engaging our island youth.
