

Relative to posthumously recognizing and honoring the late Rosa Roberto Carter, Ph.D. for her lifetime of public service in the education of her people and island community and to extending her family a sincere *un dangkolo na Si Yu'os Ma'åse'* for the outstanding contributions she had made to for the betterment of our Island Community and to further extending condolences to her family on behalf of *I Liheslaturan Guåhan* and the people of Guam.

BE IT RESOLVED BY COMMITTEE ON RULES OF I MINA'TRENTA NA LIHESLATURAN GUÅHAN:

WHEREAS, Rosa Garrido Roberto was born August 29, 1929 in *Hagåtña*. She is the daughter of the late Jose Dueñas Roberto and the late Antonia Santos Garrido Roberto, formerly of Dededo and Talofofo villages respectively. Rosa was the eldest of nine (9) children surviving infancy: three (3) brothers – Juan Garrido Roberto, Jose Garrido Roberto, and Eduardo Garrido Roberto; and five (5) sisters – Mrs. Bernadita Garrido Roberto Benavente, the late Carmen Garrido Roberto Taimañglo, Mrs. Julia Garrido Roberto Cruz,
 Mrs. Maria Garrido Roberto Blaz, and Mrs. Teresita Garrido Roberto Cruz; and

WHEREAS, Rosa and Mr. Lee Carter's courtship began in August, 1969, they were
united in the sacrament of Matrimony at St. Anthony Church in *Tamuning* on February 20,
1970; and

WHEREAS, in the early years after World War II, Rosa began her days as a full time
high school student in the mornings and for two years spent her afternoons as a full time
elementary level teacher in the public school system followed by another year of afternoons
as a librarian; and

11 WHEREAS, graduating from George Washington High School in 1950, Rosa went 12 on to earn her double major Bachelor of Science Degree in Education and History in 1954 at 13 Northern State University in Aberdeen, South Dakota; a Graduate Diploma (equivalent to a 14 U.S. master's degree) in Education in 1958 as a Fulbright Fellow at Sydney University in 15 Australia, a Master's Degree in Guidance and Counseling in 1962 at the University of 16 Northern Colorado in Greely, Colorado, and her Doctor of Philosophy (Ph.D.) degree in 17 Administration and Supervision in 1976 at Bowling Green State University in Bowling 18 Green, Ohio; and

WHEREAS, a proper education is paramount to the future prosperity of any place;
 on a small island like Guam, it is even more important to have people committed to
 teaching and educating our people; and

WHEREAS, known as Dr. Carter only since 1976, Rosa may be unique among themany great educators of Guam in that she taught in both the public and the private

systems and at every level from Kindergarten to graduate school, including *Hagåtña* Elementary, Talofofo Elementary, Adelup Elementary, and Wettengel Elementary Schools
 where she also served as an assistant principal, the Department of Youth Affairs, P C. Lujan
 Middle School, Notre Dame High School, Guam Community College, and the University of
 Guam; and

6 WHEREAS, Dr. Carter began her journey at the University of Guam in 1958 as a 7 part-time instructor at what was then called the Territorial College of Guam; she was soon 8 promoted to full-time instructor and assistant professor, and on to the ranks of associate 9 professor and later full professor. In many administrative positions at the University of 10 Guam, Rosa served the longest period as Registrar, Admissions Officer, and Director of 11 Registration. She also worked as a financial aides officer and briefly as Dean of Students; 12 and

WHEREAS, in 1977 Rosa was appointed to serve as the President of the University
and served in that position to 1983, and has remained the only woman to hold that title to
date; and

WHEREAS, Dr. Carter continued to educate the children of our island after her
retirement in 1983, taking up positions at P.C. Lujan Elementary School, the Department of
Youth Affairs, the Chamorro Language and Culture Institute, Guam Community College,
where she later served as a member of the Board of Trustees, and the *Yoña* St. Francis
Parish; and

WHEREAS, Dr. Rosa Carter led a heavy but well balanced life of leadership in civic
 organizations including the American Association of University of Women, the Guam
 Memorial Hospital Volunteers Association, the Guam Women's Club, and others, and;

WHEREAS, Dr. Carter passed away at the age of 80 on April 11, 2010 in Lee's arms
 in their Windward Hills home, Rosa Roberto Carter, Ph.D. dedicated many years of her life
 to the education of Guam and her people; and

WHEREAS, her passing leaves a void that will be felt for many years to come, in
both the family she loved and the island she served so selflessly; now, therefore, be it

6 **RESOLVED**, that the Committee on Rules certify of *I Mina'Trenta Na Liheslaturan* 7 *Guåhan* does hereby, on behalf of the people of Guam, posthumously recognize and honor 8 the late Rosa Garrido Roberto Carter, Ph.D. for her lifetime of public service in the 9 education of her people and island community and to extending her family a sincere *un* 10 *dangkolo na Si Yu'os Ma'åse* for the outstanding contributions she had made for the 11 betterment of our Island Community and to further extending condolences to her family 12 on behalf of *I Liheslaturan Guåhan* and the people of Guam; and, be it further
