1 BE IT RESOLVED BY THE COMMITTEE ON RULES OF I MINA'
2 TRENTA NA LIHESLATURAN GUÅHAN:

3 WHEREAS, on Guam, the private sector not only ensures the economic
4 success of the island, but also contributes to the overall island community;
5 and

6 WHEREAS, every year, the Guam Chamber of Commerce honors
7 leaders in the business community and companies for their dedication to
8 Guam and her people by inducting them into the Guam Business Hall of
9 Fame; and

1 **WHEREAS**, this year’s Guam Business Hall of Fame 2010 Business
2 Laureate is Foremost Foods, Inc.; and

3 **WHEREAS**, Foremost Foods began as International Dairy Supply Co.,
4 originally a milk and ice cream producer for military units on Guam that
5 commenced business with the Guam community in 1950 at the request of
6 Governor Carlton Skinner; and

7 **WHEREAS**, sixty (60) years later, Foremost Foods is one of Guam’s few
8 local producers, offering a large variety of dairy, juice, soda, and water
9 products, and operating in a state of the art plant with products distributed
10 through its own transport network to outlets around the island; and

11 **WHEREAS**, with its success, the company continues to foster a positive
12 relationship with its employees, clients, suppliers, and the community at
13 large; and

14 **WHEREAS**, Foremost Foods frequently contributes to hundreds of
15 organizations and events each year and the company and its staff support
16 numerous civic organizations, such as the American Cancer Society’s Relay
17 for Life, the *i recycle* program, various events of the Guam Chapter of
18 American Red Cross, events in the villages, events at schools and educational
19 facilities, programs to counteract such social ills as violence against women
20 and a multitude of sporting events; now therefore it be

22 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the

1 people of Guam, congratulates Foremost Foods, Inc. on its selection as the
