RELATIVE TO RECOGNIZING AND COMMENDING THE CLASS OF 1965 OF FATHER DUENAS MEMORIAL SCHOOL AS THEY CELEBRATE THEIR 45TH REUNION FROM HIGH SCHOOL AND FOR THEIR CONTRIBUTIONS TO THE COMMUNITY OF GUAM AND ROTA.

1 BE IT RESOLVED BY I MINA' TRENTA NA LIHESLATURAN GUÅHAN:

2 **WHEREAS**, a total of sixty-five (65) boys graduated from Father Memorial
3 School in 1965;

4 **WHEREAS**, many of the graduates left island to pursue higher education; and

5 **WHEREAS**, some of them stayed on Guam to pursue educational and
6 employment opportunities at home; and

7 **WHEREAS**, of those graduates that left island, many have now returned to
8 Guam in various professions to give back to the people of Guam; and

9 **WHEREAS**, in 2010, the Class of 1965 celebrate their 45th High School
10 Reunion; and

11 **WHEREAS**, as part of their reunion activities, the 1965 Alumni did car washes
12 and sold lunch plates to off set the travel cost to Rota; and

13 **WHEREAS**, 1965 Alumni traveled to Rota where they donated sports
14 equipment, books and other educational material to elementary and high school
15 students; and

16 **WHEREAS**, while in Rota, they met with elementary and high school students
17 to talk about career goals and opportunities; and

1 **WHEREAS**, the past 45 years, the alumni of Father Duenas Memorial School
2 has been actively involved in contributing to the community of Guam in numerous
3 ways, in both the private and government sector; and

4 **WHEREAS**, the 1965 Alumni has been part of the growth of the Father
5 Duenas Memorial School by supporting fundraising efforts as the Gala Event held
6 recently to raise money for their library, participates in their Annual Alumni
7 Basketball Tournament and Golf Tournaments and 5K Walk/Run events; and

8 **WHEREAS**, the 1965 Alumni have started a scholarship fund intended to give
9 to Father Duenas Memorial School graduates;

10 **WHEREAS**, to stay with the tradition, the sons of the 1965 Alumni have
11 graduated or are current students at the Father Duenas Memorial School; therefore, be

13 **RESOLVED**, *I Liheslaturan Guahan* and the People of Guam recognize and
14 commend the Class of 1965 of Father Duenas Memorial School as they celebrate their
15 45th Reunion from High School and for their contributions to Guam and Rota; and
