1 **BE IT RESOLVED BY *I MINA'TRENTA NA LIHESLATURAN***

3 **WHEREAS,** CSM Kenny S. Leon Guerrero has served as the United
4 States Army Installation and Garrison Command Sergeant Major for Fort
5 McPherson and Fort Gillem since April 2008, will be retiring soon and has
6 served the U.S. Army, honorably for over 34 years; and

7 **WHEREAS,** CSM Kenny S. Leon Guerrero, born in San Diego,
8 California, is a native son of Inarajan, Guam. Kenny entered the Army in July
9 1975. Under the Army's new initiative, One Stationed Unit Training (OSUT), he
10 attended Basic Training / Advanced Individual Training at Fort Polk, Louisiana,
11 and, following graduation, Airborne Training at Fort Benning, Georgia; and

12 **WHEREAS,** CSM Kenny S. Leon Guerrero has served in every leadership
13 position, from rifle team leader to command sergeant major. His assignments
14 include the 75th Ranger Regiment, 1st SFG-ODA151 (airborne), 25th Infantry

1 Division, Hawaii; 2nd Infantry Division, Korea; 1-509th Airborne, Fort Polk,
2 La.; 2nd ACR, 1st Battalion 19th Infantry, 2nd Battalion, 60th Mechanical
3 Infantry, the 9th Infantry, 1- 23rd Infantry Tomahawk, 1/506 (Air-Assault)
4 Infantry Regiment, Infantry Training Brigade, US Military Training Mission,
5 Saudi Arabia. CSM Kenny S. Leon Guerrero has also served as a drill sergeant at
6 Fort Benning and an operation team sergeant; and

7 **WHEREAS**, CSM Kenny S. Leon Guerrero’s military training and
8 education includes all NCO Education System courses, the Basic Leadership
9 Course, the Primary Leadership Development Course, the Basic NCO Course,
10 the Advanced NCO Course, the First Sergeant’s Course and the Sergeants Major
11 Academy. He holds an associates degree and pursuing his bachelor degree.

13 earned awards and decorations including the Defense Meritorious Service Medal,

21 **WHEREAS**, CSM Kenny S. Leon Guerrero has three children, namely,
22 Leslie Leon Guerrero, currently, employed as the Public Affairs Officer with the
23 Guam Homeland Security Office, Kenneth Leon Guerrero manages Shiny’s
24 Café located in the village of Ordot, and Jennifer Leon Guerrero, a recent
25 graduate of San Diego State with a degree in International Business; now,
