

3        **WHEREAS**, the Committee on Rules certifies that a vacancy exists in the  
4        position of Sergeant-At-Arms; and

5        **WHEREAS**, Section 22.01.01 of *I Mina' Trenta na Liheslaturan Guahan*  
6        *Otden Areklamento*, "Personnel Elected by *I Liheslaturan Guahan*" states,  
7        "The...Sergeant-at-Arms...shall be elected by the Members of *I Liheslaturan*  
8        *Guahan* as prescribed by law"; and

9        **WHEREAS**, until such time *I Liheslatura* is called into Session and can  
10        elect a Sergeant-at-Arms, Mr. Thomas V. Unsiog shall serve as the Acting  
11        Sergeant-at-Arms; and

12        **WHEREAS**, this Acting Appointment *shall* be effective August 29, 2010;
