- 7 Saipan, as well as booming tuna shipments out of Guam; and

1 WHEREAS, in 1991 CTSI built their first warehousing facility in 2 Guam for consolidated freight service operations, focusing on freight 3 forwarding as well as on growing businesses within the Pacific islands; and WHEREAS, in 1995 CTSI opened an office at the Antonio B. Won Pat 4 International Airport to better serve its growing list of customers, and in 5 1997 became an agent for foreign shipping line Mariana Express Lines, Ltd. 6 7 (MELL), opening an office at the Jose D. Leon Guerrero Commercial Port; 8 and 9 WHEREAS, the rapid expansion and globalization of businesses in the 1990s helped CTSI take its services to the next level, bringing on board 10 11 a dynamic team of information technology and logistics professionals, 12 helping the company evolve into an integrated logistics provider; and WHEREAS, in 2000, CTSI transformed from a freight forwarder to a 13 14 complete logistics solutions provider named CTSI Logistics; and 15 WHEREAS, CTSI built the first all-concrete warehouse in Guam, 16 breaking ground for its Tamuning Distribution Center in 2003, and
