WHEREAS, the Ilocano Association of Guam (ILOAG) was established fortysixth (46) years ago as a non-profit civic and social organization, whereby Ilocanos on
Guam could maintain a bond of camaraderie, friendship, and togetherness; and

WHEREAS, the Ilocano Association of Guam has been sponsoring annual 1 2 fundraising activities in order to raise money to fund its community projects; and

3 WHEREAS, over the past several years, the Ilocano Association of Guam has 4 paid for picnic shelters at Ypao Beach and at the Tamuning Mayor's Office; statues at 5 John F. Kennedy and George Washington High Schools; a lighted sign facility at the Government House; tennis courts at JFK High School; and medical equipment at the 6 7 Guam Memorial Hospital; and

8 WHEREAS, the Ilocano Association of Guam had applied for a Community 9 Development Block Grant funding from the Guam Housing and Urban Renewal 10 Authority (GHURA) for Fiscal Year 2010, with the support of Mayor Melissa Savares 11 of Dededo and the Dededo Municipal Planning Council; Senator Adolpho B. Palacios, 12 Sr., the main sponsor of Bill No. 471-30 (COR) which became Public Law No. 30-13 238; Senator Tina Rose Muña Barnes of the Committee overseeing GHURA, and cosponsor of Public Law No. 30-238; Senator Dennis G. Rodriguez, Jr., Chairman of the 14 15 Committee overseeing senior citizens; and Mr. Arthur San Agustin, now the Acting Director of the Department of Public Health and Social Services; and 16

WHEREAS, the Ilocano Association of Guam has been recently awarded a 17 federal grant of Eight Hundred Thousand Dollars (\$800,000) by GHURA to complete 18 19 its clubhouse, construct a multi-purpose community center, and a basketball court 20 facility for public usage; and

21 WHEREAS, the Ilocano Association of Guam has stipulated in their grant 22 application to GHURA that it will operate a senior citizens center and provide other 23 innovative services to the residents of the Macheche Subdivision and neighboring 24 areas; and

WHEREAS, with their planned project, the Ilocano Association of Guam 25 26 becomes the first non-profit civic Filipino organization on Guam to elevate its purpose

to the most sublime responsibility of providing services to the Community of *Dededo;* and

WHEREAS, the Ilocano Association of Guam will be celebrating their FortySixth (46th) Anniversary on March 5, 2011, with the induction of the ILOAG Officers
and Board of Directors; now, therefore, be it
