- 4 WHEREAS, on October 1978, Yvonne started working for the Government of
- 5 Guam at the Department of Public Works as a CETA worker; and
- 6 WHEREAS, on February 27, 1979, Yvonne started her career at the
- 7 Department of Public Health and Social Services as a Clerk Helper Trainee with the
- 8 Division of Public Health Nursing Section, and she was promoted one (1) day later to
- 9 General Helper; and
- 10 WHEREAS, Yvonne was promoted to Clerk I on December 12, 1979; and
- seven (7) months later she was promoted to Clerk Typist II. She then laterally
- transferred to the Division of Public Welfare Assistance Payment Section (now the
- 13 Bureau of Economic Security); and
- WHEREAS, Yvonne was promoted to Assistance Payment Worker I on May
- 15 30, 1984; and one (1) year later she was promoted to Assistance Payment Worker II
- 16 (later reclassified to Eligibility Specialist II on October 1, 1988) where her job was to
- determine the eligibility of individuals and their families for public welfare benefits;

- 19 WHEREAS, on August 27, 1990, Yvonne transferred to the Bureau of
- 20 Management Support and she was promoted to Social Services Field Representative
- 21 II, and her job was to investigate allegations of fraud and abuse of the Food Stamp and

- reclassified to Public Welfare Investigator II; a position she held until her retirement;
