3 24, 2001; and

4           **WHEREAS**, the Guam Surgicenter, LLC, was founded under the leadership of  
5 the Board of Directors: Jan Bollinger, MD; Ronald Kobayashi, MD; Jerome  
6 Landstrom, MD; Mr. William McMillan; and Mr. Joe Husslein; and founding  
7 members: John Rosoff, MD; Farrell Cole, MD; and Marlin Larsen, PhD; and

8           **WHEREAS**, the Guam Surgicenter, LLC, continues in its service to the  
9 community of Guam today under the leadership of the current Board of Directors:

11 MD; William Fell, MD; Ms. Alicia Iseke; and Mr. Michael Ysrael; and

12           **WHEREAS**, the people of Guam recognize the hard work and dedication of the  
13 owners of Guam Surgicenter, LLC, which includes Pacific Medical Management;  
14 TakeCare Insurance Co.; Jan Bollinger, MD; Jerome Landstrom, MD; Farrell Cole,  
15 MD; Jaroslav Richter, MD; Ronald Kobayashi, MD; William Fell, MD; Harvard  
16 Medical Park; Mr. Michael Ysrael; Suresh Krishnan, MD; Sung Park, MD; Saied  
17 Safabakhsh, MD; Mohammed Madantschi, MD; ABCT, Inc.; Harris Hills, LLC; RP

20           **WHEREAS**, the Guam Surgicenter, LLC, started with humble beginnings and  
21 has now grown to a staff of thirty-four (34) employees; and

22           **WHEREAS**, the Guam Surgicenter, LLC, provides invaluable medical  
23 attention to the people of Guam in dental, general, gynecology, ophthalmology,  
24 orthopedic, otorhinolaryngology, plastic, podiatry, and urology services; and

1           **WHEREAS**, in the past ten (10) years, the Guam Surgicenter, LLC, has  
2 brought in new arthroscopy equipment and instrumentation for orthopedic procedures  
3 to better service its patients; and

4           **WHEREAS**, the Guam Surgicenter assisted in bringing to Guam Dr.  
5 Fitzsimmons, the only Sports Medicine Orthopedic Surgeon. Dr. Fitzsimmons is  
6 performing the latest surgical interventions for shoulders and knees, with an emphasis  
7 on Sports Medicine, performing procedures such as Rotator Cuff Repairs and Anterior  
8 Cruciate Ligament Repairs; and they also brought to the island Dr. Fell, the only  
9 Otorhinolaryngologist (ENT); and

10          **WHEREAS**, the Guam Surgicenter, LLC,, is the only facility on Guam  
11 performing complex retinal surgery; and they have the capability to perform  
12 Extracorporeal Shock Wave Lithotripsy procedures, which is a non-invasive  
13 procedure to break up kidney stones; and

14          **WHEREAS**, since serving its first patient in 2001, the Guam Surgicenter, LLC  
15 has served nearly two thousand (2,000) patients every year; now therefore, be it

16          **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Unu Na*  
17 *Lihselaturan Guåhan* does hereby, on behalf of *I Lihselaturan Guåhan* and the people  
18 of Guam, congratulate and extend a warm *Un Dângkolo Na Si Yu'os Ma'åse'* to the  
19 Guam Surgicenter, LLC, for its dedication, and for the invaluable contributions it has  
20 made to the people of Guam over the past ten (10) years; and be it further
