- 2 occasion of the Port's Thirty-Sixth (36th) Year Anniversary, and observing "Port Week"
- 3 from October 17 to 21, 2011; and
- 4 WHEREAS, with nearly two million (2,000,000) revenue tons of cargo and
- 5 ninety-seven thousand (97,000) containers inspected and transported across its docks in
- 6 2010, the Port is essential and critical to Guam's economy and public welfare because
- 7 of our island's dependence on imported consumer goods and commodities; and
- 8 WHEREAS, the Port currently employs three hundred sixty-eight (368)
- 9 dedicated and hard-working employees to handle the Port's operations, which includes
- 10 the Stevedores, Cargo Checkers, Equipment Operators, Accountants, Tariff Specialists,
- Administrative Staff, and Managers, for the five (5) cargo handling piers, the container
- 12 yard, two (2) fuel piers, two (2) marinas, and the harbor of refuge; and
- 13 WHEREAS, the Port annually services more than eight hundred (800) vessels, to
- 14 include foreign-flagged cargo and fishing vessels; and
- WHEREAS, within the past five (5) years, the Port has been awarded more than
- One Hundred Thirty-Nine Million Dollars (\$139,000,000) in federal grants for various
- 17 projects, to include the Port modernization projects, security and maritime security
- upgrades, environmental assessments, and repairs at the *Hagåtña* and *Agat* Marinas;

- WHEREAS, in addition to their regular operations, the Port Employees have
- 21 extended their "Port Strong" spirit to the community by providing volunteer services to
- 22 Southern High School, John F. Kennedy High School, and the Department of Public

- 25 (PAGGMA) continues to support civic and charitable organizations, and events, such as

4 committed to delivering Guam's cargo in a timely and efficient manner, and to moving

5 forward with the recommendations outlined in the Master Plan Updates to transform the

6 Port into a modern facility; now therefore, be it
