12 traditions of the *Chamorro* people of Guam and the Marianas; and

16            **WHEREAS**, *I Inetnon Lalåhen Guåhan*, the Young Men’s League of Guam  
17 celebrates ninety-five (95) years of dedicated and honorable volunteer service to our  
18 island community; and

8 Men’s League of Guam has, for over fifty (50) years, assisted our Island’s youth in  
9 their educational and recreational needs, through scholarships, financial contributions,  
10 and sponsorships; and

18 Felixberto C. Flores; the late Jose Duenas – Vice President, and the brother of the late  
19 Father Jesus Baza Duenas, and the father of retired U.S. District Court Judge Cristobal  
20 C. Duenas; Manuel Ulloa – Secretary, and a prominent and long-time Guam educator;  
21 the late Adriano Cristobal – Treasurer, and the grandfather of Superior Court  
22 Presiding Judge Alberto C. Lamorena; and the late Vicente Arriola –  
23 Librarian/Historian, and the father of former Speaker Joaquin C. Arriola; the founding  
24 fathers of the Organic Act of Guam – the late Baltazar J. Bordallo, the late Eduardo T.  
25 Calvo, and the late Francisco B. Leon Guerrero; all the Governors of Guam of

1 *Chamorro* ancestry; and all other members of the YMLG, past and present; now
