3 **WHEREAS, Mr. Tommy King was born on August 11, 1954, in Selma,**
4 **Alabama, and is the proud son of Mr. and Mrs. Robert and Annie Mea King; and**

1 **WHEREAS**, Mr. Tommy King graduated from Alabama Lutheran Junior
2 College in 1974 with an Associate’s Degree in Arts, Humanities and Sciences. He
3 later enlisted in the United States Navy and was stationed at U.S. Naval Base, Guam.
4 Corporal King decided to make Guam his new home after being Honorably
5 Discharged in 1980; and

6 **WHEREAS**, Mr. Tommy King continued his service to his country by enlisting
7 as a U.S. Naval Reservist and as a Guardsman with the Guam Air National Guard. He
8 also maintained employment with the Navy Exchange, Guam and the Federal
9 Aviation Administration; and

10 **WHEREAS**, on September 29, 1989, Mr. Tommy King answered the call to
11 his chosen profession as a Corrections Officer I with the Department of Corrections
12 and was promoted to his current rank in December 2005; and

13 **WHEREAS**, throughout his career with the Department of Corrections, Mr.
14 Tommy King received numerous recognitions and citations, notably, Corrections
15 Officer of the Year, Governor’s Excel Award, and the 106th U.S. Congressional
16 Record Award; and

17 **WHEREAS**, as a devoted employee of the Department of Corrections, Mr.
18 Tommy King served as a member of the Adjustment and Classification Committee,
19 Special Operations Team, Disciplinary Hearing Board and the American Corrections
20 Association; and now, therefore be it

21 **WHEREAS**, after serving the people of Guam for twenty-five (25) years and
22 four (4) months with distinction, commitment, dedication and loyalty in the field of
23 Corrections, Mr. Tommy King retired from government service on March 24, 2012,
24 with the honorary rank of Sergeant I; now, therefore be it

25 **RESOLVED**, that the Committee on Rules *I Mina’ Trentai Unu Na*
26 *Liheslaturan Guåhan* does hereby, on behalf of the people of Guam, commend and


1 congratulate Mr. Tommy King on the occasion of his retirement as a Corporal from

8 Honorable Edward J.B. Calvo, *I Maga'lahaen Guåhan*.


