9 Mayor Roke B. Blas held other positions within the Mayors' Council such as, Vice
10 President and Sergeant-At-Arms of the Mayors' Council of Guam; Vice President of
11 the Association of Mariana Islands Mayors Vice Mayors and Elected Municipal
12 Council Members (AMIM); member of the Civilian/Military Task Force; member of
13 the Territorial Planning Council; member of the Guam Early Learning Council; and
14 member of the Department of Agriculture Tree Ordinance Working Group; and


15 **WHEREAS**, Mayor Roke B. Blas' membership in the Mayors' Council of

24 and be it further


25 **RESOLVED**, that the Speaker certify, and the Legislative Secretary attest to,
