13 Mayors Vice Mayors and Elected Municipal Council Members (AMIM); and


14 **WHEREAS**, Mayor Francisco “Frank” C. Blas’ membership in the Mayors’


25 **RESOLVED**, that the Speaker certify, and the Legislative Secretary attest to,
