10 Administration; and on April 6, 2003, he was again transferred to the General
11 Services' Agency; and

12 **WHEREAS**, since that time, Robert B. Manibusan has shown dedicated
13 professionalism and a willingness to assist, for which he was awarded the Department
14 of Administration's Special Achievement Recognition Award on June 30, 2008; and




15 **WHEREAS**, Robert's decision to retire because of age does not reflect the
