1 **BE IT RESOLVED BY THE COMMITTEE ON RULES OF *I***

3 **WHEREAS,** Colonel George “Siosi” Teo Martin was born on April 27, 1957,
4 in Munich, Germany; and he enjoyed the gift of life until his passing on July 21, 2008;
5 and

1 **WHEREAS**, Colonel Martin graduated from the Ohio State University with a
2 Bachelors of Science degree in Microbiology. He enlisted in the United States Air
3 Force in May 1981, serving as a Missile Launch Officer at Whiteman Air Force Base;
4 and

5 **WHEREAS**, Colonel Martin’s career in medicine began after he completed his
6 initial tour of duty; and he received his Doctorate of Medicine from the Ohio State
7 University College of Medicine on June 9, 1989; and

8 **WHEREAS**, in July 1990, Colonel Martin returned to active duty in the U.S.
9 Air Force as a medical doctor; and he attended Johns Hopkins residency, training in
10 emergency medicine; and

11 **WHEREAS**, in 1995, Colonel Martin was assigned to the medical office at the
12 NASA Kennedy Space Center. In August 1998, he was assigned as the Commander
13 for the Aerospace Medicine Flight 36 Medical Group at Andersen Air Force Base,
14 Guam. He was then assigned to various Air Force Bases and duties; and he eventually
15 was reassigned to Guam, working from December 2006 through 2008, and he served
16 the healthcare needs of the people of Guam; and

17 **WHEREAS**, Colonel Martin’s family, friends and the Guam Medical Society
18 come together to honor and remember the invaluable services that Colonel George
19 Teo Martin has contributed to the healthcare of the people of our island; now
20 therefore, be it

21 **RESOLVED**, that the Committee on Rules of *I Mina’Trentai Unu Na I*
22 *Liheslaturan Guåhan* does hereby, on behalf of *I Liheslaturan Guåhan* and the people
23 of Guam, posthumously recognize and commend Colonel George “Siosi” Teo Martin;
24 and does further extend a sincere *Un Dângkolo Na Si Yu’os Ma’åse’* to him for his
25 commitment and dedicated work in serving the people of Guam throughout his
26 professional years in the healthcare community; and be it further
