8 specializing in surgery. He was also board certified by the American Board of

11 on the island for twenty-nine (29) years until he passed away in 2007. He generously
12 gave of his time, and had served the island community at Family Health Plan, the
13 Guam Memorial Hospital, and the Guam Department of Public Health and Social
14 Services; and

15 **WHEREAS**, Dr. Parent's family, friends, and the Guam Medical Society have
16 come together to honor and remember the invaluable services Dr. Charles Henri


19 **RESOLVED**, that the Committee on Rules of *I Mina'Trentai Unu Na I*

4 and to the Honorable Edward J.B. Calvo, *I Maga'lahen Guåhan*.


