**BE IT RESOLVED BY THE COMMITTEE ON RULES OF

1 **WHEREAS**, Mariana Patrice Pangelinan Dimla, a student at the University of
2 San Diego, majoring in Business, decided to enter the Sons & Daughters of Guam Club
3 Liberation Queen contest in early 2011; and

4 **WHEREAS**, Mariana Patrice Pangelinan Dimla, was successful in winning the
5 title of Queen for 2011-2012 raising over \$40,000; and

6 **WHEREAS**, early on in the competition, Mariana Patrice Pangelinan Dimla
7 researched her options for donating 5% of the proceeds of the fundraiser and selected
8 the Micronesian Youth Services Network; and

9 **WHEREAS**, the Micronesian Youth Services Network (MYSN) accepted the offer
10 to be a beneficiary given that Mariana indicated her support for the values and

11 philosophies and affirmed MYSN's requirement to encourage healthy and drug free
12 lifestyles; and

13 **WHEREAS**, MYSN is an organization of individuals and organizations that
14 advocate for positive youth development, improved standards of services, and sound
15 youth services policy on Guam, the Commonwealth of the Northern Mariana Islands,
16 the Federated States of Micronesia, the Republic of Palau, the Republic of the
17 Marshalls, the Republic of Nauru and Kiribati; and

18 **WHEREAS**, the selection of MYSN by Mariana indicates her continued love for
19 her island home, her concern for the welfare of youth and families, and nurtures her
20 lifelong commitment to support and give back to her community as inspired by her
21 parents Patrick and Debbie Dimla and grandparents Arturo and Lillian Dimla and
22 Leonard Gogue and Severa Pangelinan; now, therefore, be it
