- 1 **BE IT RESOLVED BY *I MINA'TRENTAI UNU NA LIHESLATURAN***
2 ***GUÅHAN*:**
3 **WHEREAS**, the University of Guam (“University”) began as the Territorial
4 College on Guam in; and 1952 as a teacher training institution on the campus of
5 George Washington High School in Mongmong; and
6 **WHEREAS**, in 1960, the Territorial College moved to the Mangilao
7 campus, its current location, and became the College of Guam; and
8 **WHEREAS**, the University of Guam was officially named in 1968 and
9 began offering graduate study programs; and
10 **WHEREAS**, during its existence, the University has awarded nearly 12,000
11 degrees; and
12 **WHEREAS**, The University’s graduates provide the backbone of the
13 professions on Guam in business management, accounting, education, nursing,

1 environmental specialists, public administration, law enforcement and numerous
2 other fields; and

3 **WHEREAS,** The University reaches into all parts of the island and the
4 Micronesian Region through community engagement activities and extension
5 services; and

6 **WHEREAS,** The University conducts the major research activities on topics
7 related to Guam and Micronesia through its research units like the Marine Lab,
8 Micronesian Area Research Center, Water Environmental Research Institute and
9 Tropical Agricultural Research Center; and

10 **WHEREAS,** Whereas, the University of Guam will celebrate the 60th
11 anniversary of its founding in the year 2012; and

12 **WHEREAS,** Whereas, the 60th anniversary capital campaign has been
13 established, spanning a five (5) year period toward the goal of raising \$30 million
14 for UOG capital improvement projects; and

15 **WHEREAS,** Whereas, the University is embarking on this fundraising
16 campaign to build a 21st century campus; and

17 **WHEREAS,** Whereas each family and every sector of Guam's political,
18 social and economic life is tied to the success of the University; now, therefore, be
19 it

20 **RESOLVED,** that *I Mina'Trentai Unu Na Liheslaturan Guahan* does
21 hereby, on behalf of the people of Guam recognize and commend, the University
22 of Guam on its "UOG's 60th anniversary: Celebrating the Triton spirit" celebration
23 and the 60th Anniversary capital campaign; now therefore be it

25 businesses, individuals, government agencies and alumni of the University to
26 generously participate in the 60th Anniversary celebration and capital campaign,

6 of Guam Board of Regents and to the Honorable Eddie Baza Calvo, *I Maga'lahren*
7 *Guåhan*.
