

WHEREAS, SGS Guam, Inc. was established in 1989 to provide 3rd party inspection services for liquid fuels brought into Guam and currently employs seventeen (17) employees; and

WHEREAS, SGS Guam, Inc. has expanded its services to further support Guam's growth and development by providing inspection services for the island's hotel and tourism industry, the military establishment, and affiliated industries for activities related to food services and shipping & logistics services; and,
